Location: Clark Athletic Center at the University of Massachusetts Boston, 100 Morrissey Blvd., Boston MA 02125.

Course: Flat course along the ocean with a scenic view of Boston Harbor.

Entry Fee: \$17 pre-race registration postmarked on or before March 28.

UMass Boston Student rate \$10 on or before March 28. Must register in the Beacon Fitness Center and present a student I.D. with the "Spring 2008" verification sticker.

\$20 for all participants after March 28.

Directions: From North of Boston and Interstate 90: Take 93 South to exit 15, Columbia Rd. Turn left off of the exit and follow the signs to UMass Boston. Follow the signs for parking at the North Lot. Clark Athletic Center is on the opposite end of the Track.

From South of Boston: Take 93 North to exit 14, Morrissey Blvd. Stay to the right off of the exit. Take the first right into UMass Boston. Follow the signs for parking at the North Lot, Clark Athletic Center is on the opposite end of the Track.

Awards: Prizes awarded to top Male and Female finishers in the following divisions: Open, 0-29, 30-39, 40-49, 50-59, 60-69, 70+, Wheelchair.

Amenities: Showering facilities available at the finish line. Light refreshments after the run. T-Shirts to the first 200 participants. Kids' ¼ mile fun run (no cost).
